Presidents Message By: Gary Codogno, President

As the day's grow shorter it becomes our realization that another summer has gone by too fast. This seems to have been especially true this year as there appeared to be an abundance of work out for tender this past spring. From all indications, it seems that most member firms have had a sufficient work load over the past few months and the fall/winter tendering season is already upon us.

The first half of the year has been busy with numerous tendering practices issues. The City of Ottawa is continuing the use of liquidated damages and incentive/disincentive clauses, The Ottawa Hospital issued multiple public tenders with two envelope submissions and both Via Rail & BGIS continue to issue tenders with requirements for an excessive amount of information to be submitted at time of tender.

In early July we attended an OCA organized meeting with the City of Ottawa to review various aspects of their procurement process. Some of the key highlights from this meeting where.

- *The City of Ottawa is currently reviewing their data and beginning to run scenarios on how scores may affect proponent's tendered prices based on different scoring weight factors. It appears that the City could be implementing this weighted scoring system within the next year or two which may affect your tendered price.*
- *As you may or may not be aware the City of Ottawa has three standard contracts that they utilize for their procurement depending on the project size, complexity or type of project. All three of these contracts contain different wording on how change order markup's and GC's are to be processed in change orders. The OCA provided the City of Ottawa with a package of 15 front end doc's from various buyers within the Ottawa area for their review and modification of their documents. The GCAO has been requesting that the City of Ottawa standardize their markup scheme between all three contracts.*
- *The City of Ottawa noted that they will be continuing to utilize design build and CM projects more frequently over the next few years.*

Tendering Practices

The GCAO Tendering Practices Committee continues to promote adherence to approved industry standards and fair and equitable practices in competitive tendering and contract administration. The use of liquidated damages clauses and post-qualifications continues to be used by some buyers in our industry. The City of Ottawa is now using liquidated damages in order to offset administration costs for projects that run longer than scheduled.

The City (Crestview Public Pool and Change Room Facility Tender) and The Ottawa Hospital (2016 Garage Rehabilitation Program Tender) both incorporated post-tender qualifications. Member firms brought this to the attention of the GCAO and letters were sent to the City and the hospital. These were followed up with meetings with both the City of Ottawa's, Will McDonald, and the Ottawa Hospital's new Director of Facilities and Capital Development, Jill Chitra, in which the association stressed its stance on the use of post-qualifications. In both cases we were assured that this would not be the normal procedure and that pre-qualifications will be used as much as possible when practical and required.

We encourage members to continue to bring forward any concerns over unfair tendering practices, onerous Supplementary Conditions, excessively low allowable markups on change orders and two-envelope post-qualifications.

Awards year

This year marks the GCAO's 4th bi-yearly General Contractors Association of Ottawa's award program. We are very excited to introduce a new category scheme for the 2016 bi-annual awards program. The new categories will assist in ensuring that projects will be on a more level playing field as they will be monetarily closer in value. We are hoping that additional members will take advantage of this very exciting program reflecting these positive changes that have been made. Three Awards of Excellence and one Award of Merit will be given at this memorable event! The categories are as follows:

Category A – Buildings- Architectural/Commercial/Institutional

- \$0 To \$5 Million
- \$5 to \$15 Million
- \$15 Million and over

An award selection will be made from three designated project cost categories: \$0 to \$5 million, \$5 million to \$15 million and \$15 million and over for a potential of total of 3 awards of excellence.

As well as the Don Chutter Meritorious Achievement Award. Inaugurated in 2011, this award recognizes the general contractor whose efforts most improved quality of life in Ottawa.

NRDP

We would like to remind all GCAO member firms of our NRDP (Non-refundable deposits program for tendering document). We would like to encourage all member firms to participate in this advantageous program.

Some of the key highlights are as follows

- To direct the cost of tender document production to appropriate party - The Owner
- To provide each bidder with a maximum of two sets of tender documents
- To ensure that the tender documents are recycled and redistributed to the successful contractor
- To convince all owners to refund bidders the deposit of their tender documents upon the return by the unsuccessful bidders.

The procedure of the program is as follows

1. the Owner/Consultant, despite being contacted by us regarding our concerns, declines to refund the deposits
2. the non-refundable charge is in excess of \$100.00 per set of documents
3. a bidder has made a request to GCAO to invoke its policy;

As many of our members are now printing documents within their own firms, we would like to advise all members that these internal costs can be recouped via the NRD policy. We would like to encourage all member firms to provide the quantity of drawings and specs to the NRDP Director with a calculation per the following.

- \$1.10 Per page of 24 X 36" of Drawings
- \$0.20 per page of 11X17" of Drawings
- \$0.11 per page of 8.5" X11' of specification printing.
